The Hearing Officer read the proposed District Facility Plan, which includes the number one listed priority in the district being replacement of the existing Carter County Career & Technical Center. Various repair and renovation projects were summarized in lesser priorities as shown on the District Facilities Plan.
- 4. The Hearing Officer asked if anyone in attendance desired to make comments on the proposed District Facilities Plan. No one in attendance wished to make public comment.
- 5. A motion was made by Rachel Fankell and seconded by Lisa Ramey-Easterling to adjourn the hearing.

c. Accept Hearing Officer's Report

A motion was made by Lisa Ramey-Easterling and seconded by Rachel Fankell to accept the Hearing Officer's report. The motion carried with a unanimous vote of 4 to 0.
